- ITEM 1* The Community Development Department requests an amendment to Provo City Code Section 14.37.100, to reduce existing code conflicts and update parking design standards. **City Wide Impact**, 15-0011OA, Austin Corry, 801-852-6413
- ITEM 2 IHC Health Services Inc., requests Project Plan Approval for a Campus Master Plan on property owned by IHC Health Services Inc. located at approximately 1034 North 500 West, for the hospital relocation project.
